The following are the updated rates for Consular, Passport, OCI and ICWF fees, effective from the 01st February, 2026:

Ordinary fresh passport or reissue of passport containing 36 pages having validity of 10 years (also applicable to minors in the age group of 15 to 18 years).	95,250,000/-
Ordinary fresh passport or reissue of passport containing 60 pages having validity of 10 years (also applicable to minors in the age group of 15 to 18 years).	126,950,000/-
Ordinary fresh passport or reissue of passport containing 36 pages for minors below 18 years of age with validity of 05 years or till the minor attains the age of 18 years, whichever is earlier.	63,480,000/-
PASSPORTS IN LIEU OF LOST, DAMAGED OR STOLEN	
For replacement of ordinary passport of 36 pages in lieu of lost, damaged, stolen passport.	190,500,000/-

RENUNCIATION OF INDIAN NATIONALITY	
Renunciation fee on acquisition of Foreign Nationality w.e.f 01.06.2010 onwards, even for lost/damaged and passports retained by foreign governments (along with witnessing the signing of an application or declaration mentioned in rule 38 of Citizenship Rules, administering the oath of allegiance).	111,100,000/- (97,200,000/- + 13,900,000/-)

CONSULAR SERVICES

SOLEMNIZATION/REGISTRATION OF MARRIAGE	
Solemnization/ Registration of marriage and a certified copy of the entry.	63,480,000/-
MERCHANT SHIPPING	
Attestation of documents pertaining to sale, purchase, mortgage, transfer of vessel or transfer of one's interest in merchant vessel.	330,050,000/-
Attestation of other documents pertaining to ship/vessel for issue of certificate or verification or acceptance of a document or taking any action, the shipping company (or Captain of the vessel on behalf of the Company) being applicant/payee of Consular fee.	63,480,000/-
Attestation of documents issue of certificate to a sailor on "Merchant Shipping" (individual sailor being applicant for his individual use).	12,700,000/-
OTHER SERVICES	
For administration or distribution, or both of the property situated in country, of the Consular Officer's residence, of an Indian citizen or any other person, not being a seaman, dying intestate, or if not intestate, when undertaking in the absence of legally competent Representative of the deceased in country of his death or a request of legal heirs of deceased living in India as the case may be.	330,050,000/- (or 2.5% of estimated value of estate or property whichever is more)
If such property is in the country of concurrent accreditation of Consular Officer.	1,307,500,000/- (or 2.5% of estimated value of estate or property whichever is more)
Issue of succession certificate.	2.5% of estimated value of estate or property
LIFE CERTIFICATE	
Attestation of pension papers, life certificate etc pertaining to pensioners.	GRATIS
For affixing consular officer signature and seal, if required, for declaration of pay or pension	GRATIS
REGISTRATION OF DEATH	
Registration of death & a certified copy of the entry.	25,400,000/-
Cancellation of Indian passport of an Indian national who dies abroad.	GRATIS

NOTE: There shall be a discount of ten percent in passport fee for fresh applications (and not for re-issue) in respect of minors up to the age of 8 years and senior citizens (persons above the age of 60 years).

Under mentioned ICWF fee would be levied against the services mentioned above:
