<b>OTHER SERVICES</b>	
For administration or distribution, or both of the property situated in country, of the Consular Officer's residence, of an Indian citizen or any other person, not being a seaman, dying intestate, or if not intestate, when undertaking in the absence of legally competent Representative of the deceased in country of his death or a request of legal heirs of deceased living in India as the case may be.	<b>183,800,000/- (or 2.5% of estimated value of estate or property whichever is more)</b>
If such property is in the country of concurrent accreditation of Consular Officer.	<b>728,000,000/- (or 2.5% of estimated value of estate or property whichever is more)</b>
Issue of succession certificate.	<b>2.5% of estimated value of estate or property</b>
<b>LIFE CERTIFICATE</b>	
Attestation of pension papers, life certificate etc pertaining to pensioners.	<b>GRATIS</b>
For affixing consular officer signature and seal, if required, for declaration of pay or pension	<b>GRATIS</b>
<b>REGISTRATION OF DEATH</b>	
Registration of death & a certified copy of the entry.	<b>14,150,000/-</b>
Cancellation of Indian passport of an Indian national who dies abroad.	<b>GRATIS</b>

**NOTE: There shall be a discount of ten percent in passport fee for fresh applications (and not for re-issue) in respect of minors up to the age of 8 years and senior citizens (persons above the age of 60 years).**
